\$10,000 Cash Raffle – Official Rules

1. Organization

The \$10,000 Cash Raffle (“Raffle”) is conducted by the Adena Health Foundation (“Foundation”), a nonprofit 501(c)(3) organization supporting Adena Health System.

2. Purpose

Proceeds from the Raffle will support the mission and programs of the Adena Health System, benefiting patients and communities across Adena’s nine-county service area.

3. Nature of Raffle

- This Raffle is a **game of chance** conducted in accordance with applicable **State of Ohio charitable gaming laws**.
- **No portion of the ticket purchase price is tax-deductible as a charitable contribution** for federal income tax purposes.

4. Eligibility

- Participants must be **at least 18 years of age** at the time of purchase.
- Void where prohibited by law.
- Employees of Adena Health System and the Foundation are eligible to participate unless otherwise restricted by internal policy.

5. Ticket Sales

- Only **250 tickets** will be sold.
- Each ticket is **\$250**.
- Each ticket represents a **1 in 250 chance** of winning (if all tickets are sold).
- Tickets will be sold on a first-come, first-served basis.
- No refunds will be issued once a ticket is purchased.

6. Drawing

- The drawing will occur on **October 24, 2026** at The Adena Grand Gala at the Renaissance Hotel in Columbus, Ohio
- The winning ticket will be selected at random.
- Participants do not need to be present to win.
- Up to 5 people can go in together to purchase a ticket
- Purchasing multiple tickets will increase the odds of winning

7. Prize

- **\$10,000 Cash Raffle - One lucky winner will take home \$10,000!**

8. Contingency (Minimum Sales Clause)

If at least 42 tickets are sold, the winner receives the full \$10,000 prize. If fewer than 42 tickets are sold, the raffle becomes a 50/50 drawing, with half of the proceeds awarded to the winner and half supporting the Adena Health Foundation.

Raffle Prize Structure & Minimum Sales Requirement

- The grand prize is \$10,000.
- A minimum of 42 tickets sold is required to award the full \$10,000 prize.
- If 42 or more tickets are sold, one winner will receive \$10,000.
- If fewer than 42 tickets are sold, the raffle will automatically convert to a 50/50 raffle, with:
 - 50% of gross ticket revenue awarded as the prize, and
 - 50% retained by the Adena Health Foundation to support its charitable mission.

9. Odds of Winning

- Odds of winning depend on the total number of tickets sold.
- Maximum odds are **1 in 250**.

10. Tax Implications

- The prize winner is responsible for all applicable **federal, state, and local taxes**.
- In accordance with IRS regulations:
 - A **Form W-2G** will be issued if required.
 - Federal income tax withholding may apply based on current IRS thresholds.
- The winner must provide a valid Social Security Number or Taxpayer Identification Number prior to receiving the prize.
- The Foundation makes no representations regarding individual tax consequences; participants should consult their tax advisor.

11. Payment of Prize

- Prize will be paid by check from the Adena Health Foundation within **30 days of the drawing**, after all required documentation is completed.
- The winner must present valid identification matching the ticket registration.

12. Compliance with Ohio Law

This Raffle is conducted in compliance with **Ohio Revised Code Chapter 2915 (Charitable Gaming)**, including:

- The Foundation is a qualified charitable organization authorized to conduct raffles.
- No compensation is provided to individuals for conducting or assisting with the Raffle, except as permitted by law.
- All proceeds are used for charitable purposes consistent with the Foundation's mission.

13. General Conditions

- By purchasing a ticket, participants agree to be bound by these Official Rules.
- The Foundation reserves the right to:
 - Modify or cancel the Raffle to ensure compliance with applicable laws.
 - Disqualify any participant who violates these rules or tampers with the process.
- The Foundation is not responsible for lost, late, misdirected, or illegible entries.

14. Publicity

- By accepting the prize, the winner grants permission for the Foundation to use their name, likeness, and city of residence for promotional purposes, unless prohibited by law.
